THE KENT COUNTY COUNCIL
(VARIOUS ROADS, DARTFORD) (WAITING RESTRICTIONS AND
STREET PARKING PLACES) (CONSOLIDATION) ORDER 2009

Notice is hereby given that KENT COUNTY COUNCIL propose to make the above Order under sections 1(1), 2(1) to (3), 3(2), 4(1) and (2), 32(1), 35(1), 45, 46, 49 and 53 of the Road Traffic Regulation Act 1984, and of all other enabling powers, and after consultation with the chief officer of police in accordance with Part III of Schedule 9 to the Act:

The Order is being proposed following informal public consultations concerning parking and waiting in Greenhithe, Stone and Castle Wards.

In this Notice: **"DYL"** means no waiting at any time; **"SYL1"** means no waiting Mon-Fri 11am-12pm; and **"SYL2"** means no waiting Mon-Sat 8am-6pm.

"LW20" means waiting limited to 20 mins (no return within 2 hrs) 8am-6pm Mon-Sat; **"LW4"** means waiting limited to 4 hrs (no return within 4 hrs) 8am-6pm Mon-Fri.

"RP" means parking places available to qualifying residents who purchase a Residents Parking Permit. The annual cost of a residents parking permit is £50 and a business users permit is £300. Visitors permits will cost £5 for a book of 5 (max 5 books per month).

"P&D" means **"Pay and Display"** parking places available to the general public on a pay-and-display basis between 8am-6pm Mon-Fri at a tariff of £2 up to 2 hours; £4 over 4 hours with a monthly season ticket available for £60.

The effect of the Order will be to introduce new or vary existing parking and waiting restrictions in the following roads -

The Order will contain the usual exemptions to enable a vehicle to wait with police permission or for passengers to board or alight, for the loading and unloading of goods, for enabling work to be carried out in or adjacent to the road, for disabled persons and for emergency vehicles.

Full details are contained in the draft Order which, together with a statement of the Council's reasons for proposing to make the Order, a map showing the location and effect and a copy of any Orders which will be amended by the proposed Order, may be examined at the Borough Council Offices, Civic Centre, Home Gardens, Dartford, Kent, DA1 1DR (01322 343434) during normal office hours from Friday 9th October, 2009.

If you wish to object to the proposed Order you should send the grounds for your objection in writing to the Transport Engineer, Dartford Borough Council, Civic Centre, Home Gardens, Dartford, Kent, DA1 1DR by 12 noon on Monday 2nd November, 2009.
